## Swine flu manufacturers to get full legal immunity!

Secretary Kathleen Sebelius, Secretary of Health and Human Services, has signed a document that gives flu vaccine manufacturers and government officials immunity to protect them against lawsuits that could result from any side effects resulting from the Swine Flu shot.



After the flu fiasco in 1976 – where 40,000,000 people were vaccinated because of a Swine Flu outbreak at FortDix where one soldier died, they stopped the program before vaccinating the estimated 220,000,000 they had intended to give the shots. They stopped them because of the failure of the virus to be widespread and because of the adverse affects it had on those who received the shot.

There were many people who filed lawsuits and the government had to pay huge sums to those people who were adversely affected by the shot.

An actual case in dealing with side effects of medications:

"A lady had a terrible side effect from a medication. She called her doctor and he said he didn't make the medication, he just prescribed it – she called the pharmacist and he said he only filled the prescription. She called the manufacturer of the drug and they were not accountable as they only manufactured it and it was the doctor's responsibility because he wrote the prescription."

No one these days wants to be held accountable for their part or actions when things go wrong – like the **Gardasil drug** - still on the market harming young girls – 25 million shots already given and some have died and other suffering from neurological compromises.

With all the panic and vaccines made in 1976 – and given out – the pandemic they feared never happened; but many claimed they suffered from **Guillanin-Barre Syndrome** and one lady was interviewed recently, who took the shot, still today she wears braces on her legs and has terrible neurological problems.

So we find ourselves in a situation where we are encouraged to take the shot; and give it to our children to ward off this terrible flu and possibly avoid an epidemic at least; but with no assurances it will even work in all people and **no assurances** there will be **no serious side effects** and if there is – who will be held accountable?

How far can we trust our government? Or the medical community? It is almost like playing Russian roulette. There are many health care workers in Europe and Asia that refuse to take the shot and that should give us all pause to wonder.

And now they are calling for women who are pregnant to volunteer to test the vaccine. Would you take that chance with your unborn child? And if you did and something went wrong, I wonder if they tell them no one will be held accountable? Many older folks remember the awful birth defects caused by Thalidomide a morning sickness/sleeping pill drug given to pregnant women. Most of the birth defects occurred in Europe but they occurred here as well in the late 1950's and 1960's.

**Sidebar:** "Thalidomide, sleep-inducing drug found to produce skeletal defects in developing fetuses. The drug was marketed in Europe, especially in West Germany and Britain, from 1957 to 1961, and was thought to be so safe that it was sold without prescription. In 1961 an extremely high incidence of European babies born with malformed, shortened limbs was correlated with use of Thalidomide by women in their first trimester of pregnancy. Before it was recalled from use, the drug had caused the malformation of about 8,000 children throughout the world".

No one can tell another what to do in such a case as either could have severe consequences. A dilemma for sure for any expectant mother particularly given the story of the young pregnant mother who died recently of the Swine Flu – and she delivered her child but never lived to see its little face.

And on the other hand – do you weigh the effects of an untested flu vaccine against the possibility of getting the flu? Pregnant women are told not even to eat fish because of the Mercury to not use cough medications which might harm their unborn child.
